# FY 2017 Annual Report: Jen Desimone

Jen Desimone summarized the detailed events and administrative activities of the past year.

Major accomplishments include:

- \$67,400 cash sponsorships and \$75,000 worth of in-kind support.
- Campaign included digital radio, online, social media, and transit advertising.
- 145 million media impressions.
- 75,000 page views to the web site.

- Expanded social media platforms (Facebook and Twitter) by 13%.
- Air quality information presented to nearly 5,000 students.
- Conferred 18 annual science fair awards in ten jurisdictions.
- Conducted a poster and slogan contest.
- Participated in a ten local events and festivals.
- Initiatives for the USA Science and Engineering Festival, Air Quality Awareness Week, #BreatheEasy Concert, and Car Free Day
- Distributed more than 2,500 pieces of materials including a magnets and rack cards.
- Mobile application downloaded more than 4,500 times, 11% increase.
- 20<sup>th</sup> Anniversary Celebration and Awards event.

# FY 2018 Work Program and Budget: Jen Desimone

The FY 2018 work program and budget was presented to the Board.

The FY 2018 budget is \$662,797. The State DOT's and COG contribute 77% of the budget. Sponsorships account for 11%, and carry-over contributes 12%. The FY 2018 budget decreased by 1% due to lower estimated carry-over amount.

The work program is broken into 4 program areas including:

- 1. Education and Outreach 50% of total expenditures
- 2. Marketing and Public Awareness 34% of total expenditures
- 3. Special Projects 5% of total expenditures
- 4. Program Administration 11% of total expenditures

The work program includes one priority, unfunded projects: curriculum redesign. Staff estimates the curriculum costs will range from \$60 - \$75k and will explore grants to fund the project.

The Board voted and unanimously approved the work program and budget.
