Mike Sowko, National Weather Service

Mr. Sowko is the acting Chief of National Weather Service's (NWS) Performance and Evaluation Branch and Team Lead for the NWS Operation Center. Mike has nearly 20 years of federal service at NOAA, specifically as a meteorologist, which has fostered a passion for clean air. He routinely provides briefings to high level government officials, facilitates interagency outreach and engagement events, and is a subject matter expert for the NWS's strategic planning initiative - EVOLVE NWS. Mike has a B.S. in atmospheric science from The Ohio State University and a M.A. Public Administration and Policy from American University.

Robin Rubin, Lyft

Robin Rubin is the Community Strategist for Lyft, overseeing public engagement and policy partnerships in the Mid-Atlantic. Prior to joining Lyft, Robin served as Associate Director of the Office of Federal and Regionals Affairs (OFRA), in the Executive Office of Mayor Muriel E. Bowser. In this role, she led strategies to advance the policy objectives of the District of Columbia with Congress, federal agencies, and regional governments. During her tenure, she secured bipartisan support for District initiatives, including: priority transportation projects; removal of Congressional oversight; and increased funding for the Emergency Planning and Security Fund (EPSF).

Prior to serving in Mayor Bowser's administration, Robin was the Director of Government Relations & Associate Director of the Philanthropy Practice at Van Scoyoc Associates (VSA), a DC-based federal government affairs firm. In this role, Robin was the chief advocate and lobbyist on legislative proposals, administrative regulations, and public policy issues before Congress and the Executive Branch regarding non-profit tax issues. As part of her work, Robin managed the federal relations strategy for the Community Foundation Public Awareness Initiative, a coalition of more than 125 community foundations in 48 states, and the District of Columbia.

In 2008, Robin joined then Senator Barack Obama's campaign for president, running field operations and voter outreach in Pennsylvania, West Virginia, Kentucky, Illinois, and Florida. After the election, she was appointed Special Assistant to the Agency Review department on the Presidential Transition Team.

Robin holds a Bachelor of Arts in Political Science from Penn State University.
